#### A Treasure Found at Sea

While transiting the Columbia River to return the new double hull barge, NATHAN SCHMIDT to Seattle, the CF CAMPBELL snagged a true treasure from sea. It is assumed that as the tug laid out the tow wire in preparation for the long trip home, it snagged the anchor pictured to the right. The anchor was then carried all the way up to Seattle and not discovered until the tow wire was shortened up to make up to the barge for docking at Pier 23.

When crew and shoreside maintenance pulled the anchor back to shore, it was like something from a movie as the anchor was wrapped in a fish net.



The anchor appears to be between 80-120 years old and was likely used on an old ship that transited the Columbia River. At this point we can only guess and imagine the possibilities of where the anchor came from.

Our new treasure now sits at the end of the Harley Marine dock in Seattle. We have also taken a piece of the anchor to a lab to be carbon dated. More details, if any received, will be provided in a later edition.


#### NATHAN SCHMIDT CHRISTENING

#### **Near Miss**

For every serious injury, there are 10 minor injuries, 30 property damage incidents, and 600 "near misses" where no injury or damage occurs. This is known as the "near miss pyramid".

By investigating and sharing the "near misses" which occur in our workplace, we greatly affect our ability to prevent more serious accidents, or even death, from occurring. If we reduce the number of near misses, probability tells us we will then reduce the number of injuries that happen. Investigating near



misses can save you and the company a world of grief by getting to the root causes of near misses, thereby lessening the chances of injuries to workers or damage to valuable equipment and inventory.

#### What is a "Near Miss"?

A near-miss is defined as an unintentional unsafe occurrence that could have resulted in an injury, fatality, or property damage. Only a fortunate break in the chain of events prevented an injury, fatality or damage.

#### The same things that cause accidents cause Near Misses:

- Unsafe acts such as improper lifting, walking under an overhead load, cutting, grinding, or chipping without safety glasses, not using proper Personal Protective Equipment, etc.
- Unsafe conditions such as poorly maintained equipment, oil or grease on decks, welding leads that have been laid in walkways, trash and boxes that have been left in hallways, etc.
- Hurrying and taking risks to get a job done faster, or to wrap up a job.

#### Why should you submit a near-miss report?

A near miss experienced by you or a fellow crew member can improve the knowledge, skills and abilities of everyone who is made aware of it. Reporting a near-miss may help prevent an injury or fatality. Near-miss reporting has worked effectively in other industries, especially aviation, since team members have more knowledge. Industries using near-miss reporting systems have lower injury rates and fewer worker fatalities.

#### What are the main goals of Near Miss Reporting?

To give crews and management the opportunity to learn from each other through real-life experiences; to help formulate strategies to reduce the frequency of injuries and fatalities; to enhance the safety culture of the company.

#### Who can submit a report?

Any employee is encouraged to submit a report when he/she is involved in, witnesses, or is told of a near-miss event. Report each and every near miss incident to your supervisor immediately in order to help prompt investigation and follow up.

#### **Near Misses Are A Warning**

If you are involved with or witness a near miss incident, remember that you or your co-worker may not get a second injury free chance to hoist that red warning flag up the pole. Do your part to help make the workplace safe for everyone involved. Letting a near miss go unreported provides an opportunity for a serious accident to occur. Correcting these actions or conditions will enhance the safety within your facility or on your vessel, and provide a better working environment for everyone involved. Don't let yourself or co-workers become statistics-report near misses to your supervisor. Remember-HMS Near Miss Reporting is a voluntary, non-punitive reporting system used by witnesses to help make our company safer.

#### **Q** Factor

Recently, there has been some confusion between the DPA and QI (Qualified Individual). The following definitions will help to clarify these two important roles.

#### What is the DPA's role?

**DPA (Designated Person Ashore)** - Provides a direct link between personnel on board and highest level of management to ensure quality, safe and environmental responsible operations. Responsibilities and authority include monitoring the quality, safety and pollution prevention aspects of the operation of each vessel and to ensure that adequate resources and shore based support are applied, as required.



#### Walking

According to the National Sporting Goods
Association, the number of Americans walking as
a form of exercise has skyrocketed from 41 million
in 1985 to 70 million in 1995. Today, exercise
walking ranks as the number one fitness sport—
ahead of swimming, biking and aerobics.

"A lot of people have the misconception that to be beneficial, exercise must be grim and punishing," says James M. Rippe, MD, director of the Center for Clinical and Lifestyle Research in Shrewsbury, Massachusetts. "They try something that's not



suitable for them, get sore and discouraged and have an awful experience. For the vast majority, brisk walking is the perfect solution."

Research conducted by the University of North Carolina's Department of Medicine demonstrates that a weekly regimen of walking three times a week, 20 minutes a day lowers blood pressure, increases HPL levels (good cholesterol) and aids in weight loss. Clinical sports psychologist Kate Harp, Ph.D. reports that walking can even help problem solving abilities; during exercise, the brain relies more on the creative right side and less on the rigid left side.

For best walking results, do a posture check:

- ♦ Stomach should be held firm
- Do not look down
- Arms should be at right angles and swinging straight forward
- Once you establish a pace, roll your hips forward and back

# Cooking With the Captain Captain Chris Starkenburg "Eggplant Parmesan"

#### Ingredients:

2 lbs.	Egg Plant (2 medium sized)		Breading	
1 tbs.	Kosher Salt	3 cups	Panko Bread Crumbs	
Seasoned Flour		1 cup	Regular Bread Crumbs	
2 cups	All Purpose Flour	1/2 cup	Grated Parmesan Cheese	
1 tbs.	Italian Seasoning	2 tbls.	Parsley Flake	
2 tsp.	Kosher Salt	1 1/2 quarts	Marinara Sauce	
1 tsp.	Black Pepper	2 lbs.	Fresh Mozzarella	
2 tsp.	Whole Oregano	1lbs.	Fresh Grated Parmesan & Asiago Cheese	
1/2 tsp.	Crushed Red Chili	1 oz.	Fresh Basil Garnish	
Egg Wash			Crushed Red Chili (garnish)	
4	Large Eggs	4-5 cups	Vegetable Oil	
1 cup	Milk			

#### Directions:

- 1. Slice eggplant into wheels about 1/4 inch thick. Lightly sprinkle both sides with Kosher Salt and place on a cookie rack (this will make the eggplant sweat a little).
- 2. Mix the seasoned flour ingredients together and place in a bowl. BOWL #1
- 3. Whisk the eggs and milk together and place in a bowl. BOWL #2
- 4. Mix the breading ingredients together and place in a bowl. BOWL #3
- 5. Warm up the marinara sauce on the stove top and keep warm.
- 6. In a heavy bottom skillet, on medium heat, slowly warm up 2-3 cups of vegetable oil.
- 7. Place the three bowls in order, BOWL #1 Seasoned Flour, BOWL #2 Egg Wash, and BOWL #3 Breading Mixture.
- 8. Pat dry the eggplant with a paper towel.
- 9. Place the eggplant in BOWL #1, shake off the excess and transfer to BOWL #2. Coat the egg plant completely with the egg wash and then transfer to BOWL #3. After coating both sides with the breading mixture, place the egg plant on a foil covered baking sheet. Repeat this step until all the eggplant is coated.
- 10. Slice the fresh Mozzarella and set aside.
- 11. Roll the basil leafs and cross slice it as thin as you can.
- 12. Turn up the heat on the vegetable oil until it reaches about 325°-350°F.
- 13. Carefully fry each slice of the eggplant until it is golden brown. Place on the cookie rack and sprinkle with Parmesan Cheese while it is still hot. Place in the oven to keep warm while you finish frying the remaining eggplant.

#### **Plating Directions:**

- 1. Place a small ladle of marinara sauce on an oven proof plate.
- 2. Place 3-4 slices of eggplant in the center and ladle more marinara sauce over the top, but don't cover completely.
- 3. Place a few slices of fresh Mozzarella on top and generously sprinkle with Parmesan Cheese.
- 4. Place in a pre-heated 350°F oven for 10-12 minutes.
- 5. Carefully remove from the oven and garnish with fresh basil and crushed red chili flakes.
